YELLOWSTONE ACADEMY IS A PRIVATE, FAITH BASED SCHOOL IN HOUSTON'S THIRD WARD THAT SERVES STUDENTS FROM PRE-K THROUGH THE 8TH GRADE, AND ALUMNI ATTENDING VARIOUS HIGH SCHOOLS IN HOUSTON. YELLOWSTONE ACADEMY OPENED ON AUGUST 21, 2002 WITH FOUR CLASSES OF THREE AND FOUR YEAR OLD STUDENTS. IN AUGUST 2018, THE ACADEMY REDUCED GRADE LEVELS FROM PRE-K THROUGH 8TH GRADE DOWN TO PRE-K THROUGH 4TH GRADE TO MAKE SPACE FOR A NEW CHARTER SCHOOL THAT WOULD CARRY GRADES 5 THROUGH 8 WITH PLANS TO EDUCATE STUDENTS THROUGH THE 12TH GRADE. DURING THE 2019 - 2020 SCHOOL YEAR, YELLOWSTONE ACADEMY SERVED 218 STUDENTS FROM PRE-KINDERGARTEN THROUGH THE FOURTH GRADE AND AN ADDITIONAL 137 ALUMNI THROUGH THE HIGH SCHOOL SUPPORT PROGRAM.
